But these children cannot be blamed. As a parent, you must be able to look at the circumstances and decide to allow them to participate. As a child, there is no way to control what their life is going to be like and there is no way to predict how they will respond to any circumstances. What parents can control is what happens when a child tells you what they think, when they need something or what they like about you. I have noticed that at least two out of three of my students know what is okay for them to say when they want to say something. They are not being told to just say it, but if the parent doesn't tell the child what he or she wants or feels comfortable with, the child will never hear and therefore there will be consequences. In the cases I have had, the parents who asked my children to say something and who never did or refused to say anything were very surprised and surprised me that they listened to my question and that they didn't go through with it even though many didn't know what would happen or feel that there were consequences..
